Al Betz and Robert Sherwood

Until very recently the identity of personality traits was limited to high-ranking executive titles in an organization. Robert J. Sherwood, a former Silicon Valley technology executive, is among the first to create an algorithm to quickly, accurately, and inexpensively identify the traits of all candidates for employment and employees seeking advancement to new opportunities. TREK42 is the method he and Al Betz will introduce in explaining what traits are, what they mean, and how court reporters can use their traits to deal with inevitable change. In addition, Mr. Sherwood will present a technology review of developments and trends and their impact on court reporting careers. With a newfound knowledge of traits comes the need to effectively communicate them.

Mr. Betz will present a segment on silent communication, including how to inspire a performance, the art of constant messaging, and he will share a few of his favorite on-the-job silent communicators. Court Reporters will learn the following: How to manage change through a better understanding of themselves, Why knowledge of their personal traits can lead to an enlightened world view and improved relationships, New communication skills.



Al Betz has been known as court reporter, pioneer, entrepreneur, author, CEO, volunteer, podcast host, coach, and public speaker. Al's life philosophy is that daily achievements lead to significant accomplishments. Whether reading 10 pages from a favorite book, interviewing a business leader on his podcast, or signing an important contract, Al experiences personal and/or professional growth every day.

His business career began at age 19, and 50 plus years later he remains active, and he enjoys learning, communicating, and creating. His favorite topics are silent communication and inspired performance. "Not one human being is ever taught how to communicate, and we see the results of it daily

in our homes and in the workplace." Al learned the value of an inspired performance at a Kenny G concert. He applied what he saw to his own performance, and it changed his life.



Robert Sherwood has authored 14 books, hosted his own radio program, taught at KU, MU and Stanford graduate schools of business, earned MBA and MS degrees, received an honorary doctorate, founded 2 Silicon Valley technology companies and directed businesses in South Africa, Europe, and the Middle East. He was president and founder of a venture capital firm capitalized by Ewing Kauffman, past owner of the Kansas City Royals.

He has been a senior board member to 30 companies, was profiled in Fortune and Businessweek, was the winner of the 1995 Entrepreneur of the Year, sponsored by Ernst & Young, NASDAQ and Inc. Magazine,

presented seminars on Leadership and Technology to more than 3000 executives, and as an Expert Witness, he has testified in court on behalf of such prominent companies as Google, Yahoo! and Facebook. He holds a Series 65 license which covers laws, regulations, ethics, retirement planning and portfolio management. His consulting practice includes technology product development, leadership training and professional coaching. He has been married for 44 years to Helen and has five sons.

How to Prepare for High-Profile Cases with Judith Bellinger and Cynthia G. Wright



Judith Bellinger, RPR, CRR, has been a freelance court stenographer since 1984, after having graduated from the Academy of Court Reporting in Cleveland, Ohio.

She was an instructor at the Stenotype Institute in Indianapolis, Indiana. She also served as president of the Indiana Shorthand Reporters Association and has also served on several committees.

She provides her outstanding realtime services all across the country on high-profile depositions and trials, including, most recently, Depp v. Heard in Virginia; a 10-week murder trial in Indiana, State v. Camm; services of

professional sports leagues, and many more.

She also provides her exemplary court reporting services to unions during their annual conventions, has provided CART services to students of Indiana University—Purdue University Indianapolis, to the former Wishard Hospital, and The Indiana School for the Deaf. She considers her career a passion, not a job.



Cynthia G. Wright, Esq. is Assistant Disciplinary Counsel for the District of Columbia. She was an Assistant U.S. Attorney in the District of Columbia where she was a Senior Homicide prosecutor specializing in cases involving the death of children. She has prosecuted hundreds of cases, including numerous child homicides, violent street gangs, domestic violence homicides, child sexual abuse cases, child pornography, and sex trafficking cases, as well as numerous attorneys charged with contempt of court. Ms. Wright served as Deputy Chief of the Felony Trial Section from 2003 until 2007 and Acting Chief of the Victim/Witness Assistance Division in 2007 and 2008, and as Senior Litigation Counsel. Ms. Wright also worked at the Security Exchange

Commission and worked on various fraud cases, subprime mortgage fraud and CDO cases.


Ms. Wright prosecuted *United States v. Carlos Curtis*, one of the first sex trafficking cases in the United States presented to a jury. Curtis received a life sentence for prostituting girls as young as twelve-years-old. She received the Department of Justice Director's Award for her work in the *Curtis* case. She has earned seventeen Special Achievement Awards while at the U.S. Attorney's Office.


Ms. Wright was appointed by the U.S. Attorney and Mayor of the District of Columbia to serve as Co-Chair of the Child Fatality Review Committee and as Co-Chair for the Infant Mortality Review Committee for the District of Columbia in reviewing the deaths of children in the District of Columbia. She served as President, Bryant Inn of Court, President of D.C. Barristers, and Chair of the D.C. Court of Appeals Committee on Unauthorized Practice of Law.





<u>MEMORY POWER, Have You Lost Your Mind?!</u> <u>with Paul Mellor, Expert Memory Trainer</u>



Paul Mellor, author of *Finding the Keys*, was a finalist in the USA Memory Championship, where he recalled the names of over 90 people in less than 15 minutes, remembered in exact order over 100 single-digit numbers after a five-minute study, and recalled the exact order of a shuffled deck of playing cards after less than a three-and-a-half minute review.
